The International Input-Output Association (IIOA) and the Research Unit on Complexity and Economics (UECE), announces that the 22nd International Input-Output Conference will be held on 15th – 18th July, 2014, at the School of Economics and Management (ISEG) of the University of Lisbon, Lisbon, Portugal.

Goal of the conference

The goal of the conference is to promote and stimulate the worldwide exchange of ideas among economists between them and government officials, policy makers, engineers, statisticians and managers with interests in input-output analysis and related methods.

Mode of Participation

Planned/Organized Sessions

At past International Input-Output Conferences, pre-planned sessions organized by attendees have been most successful in terms of the number of attendance and participant interaction. For this reason, we strongly encourage proposals for sets of thematic sessions. In proposing such sessions or sets of sessions, as soon as is possible please send the Chair of the Scientific Program Committee an e-mail including the name(s) of the organizer(s), an abstract describing the theme/objectives for the session(s), names and institutional affiliations of the session chair(s) and presenters as well as an abstract for each paper to be included in the session.

Individual submissions

The majority of papers at International I-O Conferences tend to be submitted this way. We ask that author(s) submit their names, institutional affiliation(s), the paper title and an abstract of the presentation (of not more than 300 but not less than 200 words) and select a topic from the list provided. Abstracts are reviewed by members of the scientific committee before they can be accepted for inclusion in the conference program. An author is permitted to *present* a maximum of two papers at the conference but can of course be a co-author of a number of submitted papers.

Submission of abstracts

Please submit abstracts for papers before **January 24**, **2014** through the new online abstract submission system COPASS: **http://copass.iioa.org**. Please, fill in the requested data (title, abstract, names of all authors, e-mail address, preferred day of presentation, etc.) and select an appropriate topic for the abstract. The length of the abstract should not exceed the maximum allowed by the system.

Submission of full papers

A paper with more than **2,000 words** shall be considered a full paper for the submission. The full paper should be sent in PDF format using **http://copass.iioa.org**. To secure a spot on the final program please submit a completed electronic version of the paper not later than **May 9**, **2014**.

Travel Grants

The IIOA has limited funds to encourage **young experts from non-OECD member countries** to attend the conference. As many as ten awards in amounts of up to US \$2,500 each are available. Applicants must be IIOA members born after 1973. They must also present an unpublished paper and have not received travel grants in any of the three previous International I-O Conferences. The Travel Grant Committee of the IIOA will verify applicant qualifications and bestow the award to those qualified applicants with the most promising papers. Authors who wish to apply for a travel grant should submit their **full paper** to the Chair of the Scientific Program Committee and the Chair of the Local Organizing Committee by **March 14, 2014**.

Leontief Memorial Prize

The IIOA is pleased to announce a Leontief Memorial Prize 2014 for the **best conference paper of young authors** (born after 1973, unpublished work, work combining theory and application) of the forthcoming International Input-Output Conference in Lisbon. All co-authors must meet the "young author" requirements. The Leontief Memorial Prize Committee of the IIOA will verify applicant qualifications and select the winning paper, which will be published in *Economic Systems Research*. Authors who want to compete for the 2014 Leontief Memorial Prize should submit their **full paper** to the Chair of the Scientific Program Committee and the Chair of the Local Organizing Committee by **March 14, 2014**.

Program and book of abstracts

The final program and the book of abstracts will include only papers for which at least one author has registered the conference **and sent the full paper (of at least 2,000 words) by May 9, 2014**. After this date, only co-authors of already registered and accepted papers and other participants without presentations will be allowed to register. Please, be aware that conference fees are not be reimbursed if any author decides not to attend. Authors with an accepted abstract that have <u>not registered</u> for the conference until June 30.2014, must face the possibility to be removed from the final program in order to minimize the number of cancellations of presentations.
